

Cookie Policy

This Cookie Policy explains how Betinal Private Limited ("Betinal," "we," "us," or "our") uses cookies and similar tracking technologies on the Cynotics mobile application (the "App"). By using the App, you consent to the use of cookies as described in this policy.

What are Cookies?

1.1 Cookies are small text files that are placed on your device when you access or use the app. They are widely used to enhance your browsing experience and provide certain functionality.

1.2 Cookies may be session cookies, which are temporary and deleted when you close the app, or persistent cookies, which remain on your device for a longer period or until you manually delete them.

How We Use Cookies:

2.1 **Essential Cookies:** We use essential cookies that are necessary for the operation of the app and to provide you with the requested services. These cookies enable basic functionality, such as user authentication and security.

2.2 **Analytics Cookies:** We use analytics cookies to collect information about how you interact with the app, including the pages you visit, the time spent on each page, and any errors encountered. This information helps us improve the performance and usability of the app.

2.3 **Functionality Cookies:** We use functionality cookies to remember your preferences and settings, such as language preferences, and to provide enhanced features and personalised content.

2.4 **Third-Party Cookies:** We may allow third-party service providers to place cookies on your device to collect information about your browsing activities. These cookies are subject to the respective third parties' privacy policies, and we recommend reviewing those policies for more information.

Your Cookie Choices:

3.1 **Cookie Consent:** By continuing to use the app, you consent to the placement of cookies on your device as described in this Policy.

3.2 **Opt-Out:** If you prefer not to accept cookies, you can modify your browser settings to refuse cookies or to alert you when cookies are being sent. However, please note that blocking or deleting cookies may impact your experience and the functionality of the app.

3.3 **Do Not Track:** Some web browsers offer a "Do Not Track" ("DNT") feature. At present, the app does not respond to DNT signals, as there is no universally accepted standard for how DNT should be interpreted or implemented.
